

AN ORDINANCE approving a contract for solid waste and single-stream recycling collection, disposal, and processing services for single-family and duplex residential living units, as well as for City owned buildings, facilities, and operations; and dealing generally with the residential trash service established by Ordinance in 2004; and adding City facilities to said contract/agreement; and authorizing the Director of Public Works to execute the same by and on behalf of the City of Joplin, and containing an emergency clause.

WHEREAS, since April 1, 2004 the City of Joplin has managed residential trash service through an exclusive franchised agreement and said agreement expires on March 31, 2016; and

WHEREAS, the City of Joplin accepted three competitive, sealed Proposals (RFP #101-2016) on December 15, 2015 for residential trash service, City of Joplin operations trash service, and single-stream recycling services; and

WHEREAS, the City of Joplin desires to continue the residential trash service management through a new exclusive agreement with the start date of April 1, 2016; and

WHEREAS, the City of Joplin buildings, facilities, and operations generate solid waste and recyclables through the course of doing business and desires to combine these services with the residential agreement for the proper collection, hauling, disposal, and processing of said solid waste and recyclables; and

WHEREAS, the City of Joplin desires to add single-stream curbside recycling for single-family and duplexes, and to select City facilities within the same agreement; and

WHEREAS, the City's FY2015-2016 budget provides for "sanitation charges" and "residential trash administration" and the FY2016-2017 budget will provide for same; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JOPLIN, MISSOURI, as follows:

Section 1. That the Solid Waste Collection and Recycling Services Agreement by and between the City of Joplin, Missouri, a Municipal Corporation, and Waste Corporation of Missouri, Inc., the same being attached hereto and is incorporated herein as "Attachment A."

Section 2. That the Director of Public Works is hereby authorized and directed to execute said contract, in substantial conformance to that attached hereto, by and on behalf of the City of Joplin, Missouri.

Section 3. This ordinance is an emergency within the means of Section 2.12 (1) of the Joplin City Charter, in that said ordinance provides for the protection and preservation the public health of the community by ensuring the uninterrupted collection and disposal of solid waste thereby minimizing the proliferation of vermin and unsanitary conditions within the community.
