

**JOPLIN CITY COUNCIL  
JANUARY 19, 2021  
MEETING MINUTES**

**CALL TO ORDER**

The January 19, 2021 regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Ryan Stanley.

**INVOCATION** was read by City Clerk Barbara Gollhofer.

**PLEDGE OF ALLEGIANCE** to the United States of America was led by Dr. Reid Adams.

**ROLL CALL**

Answering Roll Call were Council Members: Charles Copple, Keenan Cortez, Doug Lawson, Anthony Monteleone, Diane Reid Adams, Gary Shaw, Mayor Ryan Stanley, Phil Stinnett and Christina Williams. Also, in attendance were City Manager Nick Edwards and City Attorney Peter Edwards.

**PRESENTATIONS**

Abigail Surbrugg presented an update of Joplin High School events and activities.

**FINALIZATION OF CONSENT AGENDA**

There being no further business to come before the Council, the Consent Agenda was finalized.

**REPORTS AND COMMUNICATIONS**

**COVID-19 Needs/Assessment Update:** presented by Finance Director Leslie Haase. The overview included possible future Covid-19 service needs; reimbursement status of County Cares Funds; possible Covid-19 funding sources beyond December 31, 2020; estimated costs of future service needs; and Next Steps.

**Health Department Update:** presented by Health Director Ryan Talken. Mr. Talken stated there is an average of 24 Covid cases per day; to date, there have been 5,229 positive Covid cases confirmed in Joplin; 27 Joplin residents are currently hospitalized with a total combined hospital occupancy of 58. Mr. Talken stated the numbers have flattened a bit, but to continue following the CDC guidelines for prevention. The State's vaccine distribution plan is divided into priority phases due to a limited supply of the vaccine. Currently, the plan is at Phase 1B -Tier 1. There are 25 sites in the Joplin area that are authorized to administer the vaccine as it becomes more available.

**News from Public Information Officer Lynn Onstot**

The City's tree limb and brush drop-off site will open every third Saturday, starting on Saturday, February 20, from 8:30 a.m. to 2 p.m. This program will be open the third Saturday of the month from February through October. The site is located at 1702 North Schifferdecker Avenue, about a half mile north of Belle Center Road on the west side of Schifferdecker. Joplin residents always have the option to put limbs out with their residential trash service through Republic Services. Limbs should be cut to four feet maximum and bundled, weighing no more than 50 pounds.

The City of Joplin and Jasper County Health Departments announce a community COVID-19 testing site will be offered on Friday, January 22 at Access Family Care, 530 S. Maiden Lane in Joplin. Testing will be done from 9 a.m. to 1 p.m. on Friday, January 22, 2021. According to the Missouri Department of Health and Senior Services, Missouri residency is the only requirement; individuals do not have to live in the county in which they are tested, and they do not have to be experiencing symptoms. Missouri residents who wish to be tested with an anterior nasal swab to determine if they have an active COVID-19 infection can do so at no cost to the individual. Missourians can register online for testing events at [health.mo.gov/communitytest](https://health.mo.gov/communitytest) and click on this date and location option.

And as a reminder for the vaccine: Citizens should watch for future announcements about vaccination opportunities in our area. The City's Health Department has not received vaccine yet, however, the department is working with their healthcare partners in planning vaccination clinics. As vaccine is shipped to our area, the City's Health Department, along with Jasper County Health Department will announce details of the clinics, as some of the logistics are still being finalized. The vaccines will be given to individuals qualifying in the tier groups identified by the State of Missouri in their vaccination plan. Missouri's phased approach to vaccinating citizens allows us to protect the most vulnerable among us, as well as populations who work to keep our communities safe and thriving during an emergency. Mr. Copple introduced Council Bill No. 2021-400 - an ordinance approving an Agreement between the City of Joplin, Missouri, and Economic Security Corporation of Southwest Area that pertains to 2019 HOME funds; authorizing the City Manager or his designee to execute same on behalf of the City. Motion by Mr. Copple, second by Mr. Lawson that Council Bill No. 2021-400 be passed on First Reading and advanced to Second and Third Reading. Voting in favor were Council Members: Copple, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett and Williams, 9. Nays: 0. The Council Bill was read as **Council Bill No. 2021-400**

COUNCIL BILL NO. 2021-401

Mr. Monteleone introduced Council Bill No. 2021-401 - an ordinance authorizing the City of Joplin to enter into an Agreement with Olsson Associates for Transportation Planning Services relating to an Active Transportation Assessment for the City of Joplin. Motion by Mr. Monteleone, second by Mr. Cortez that Council Bill No. 2021-401 be passed on First Reading and advanced to Second and Third Reading. Voting in favor were Council Members: Copple, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett and Williams, 9. Nays: 0. The Council Bill was read as **Council Bill No. 2021-401**

Mr. Copple asked City Manager Edwards to provide more information regarding the Essential Air Service agreement with SkyWest; specifically, the background and methodology on how the decision was made to use SkyWest. Mr. Edwards stated he would provide a response to the concerns that were presented.


Mr. Stinnett echoed Mr. Copple's concern regarding clarification of whether accumulated airline points from American Airlines can be transferred to United Airlines. Mr. Stinnett also commented on the limb drop-off process and the possibility of extending the hours of service.
