

**JOPLIN CITY COUNCIL
FEBRUARY 3, 2020
MEETING MINUTES**

CALL TO ORDER

The regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Gary Shaw.

Motion by Mr. Lawson, second by Dr. Reid Adams that Council Bill No. 2020-105 be approved on an emergency basis. Mr. Stanley introduced Council Bill No. 2020-107 - an ordinance approving a construction agreement with Vance Brothers Inc. for street microsurfacing in the not to exceed amount Seven Hundred Eighteen Thousand Nine Hundred Ninety and 14/100 Dollars (\$718,990.14) for the 2020 Microsurfacing Project; and containing an emergency clause. Motion by Mr. Stanley, second by Mr. Cortez that Council Bill No. 2020-107 be approved on an emergency basis. Voting in favor were Council Members: Brown, Colbert-Kean, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley and Stinnett, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance No. 2020-015**

Mr. Stinnett introduced Council Bill No. 2020-400 - an ordinance authorizing the City of Joplin to execute Work Authorization #6 to the Master Services Agreement for Professional Administrative Consulting Services with Guidehouse LLC (GH) formerly known as PricewaterhouseCoopers Public Sector LLP (PwC) to provide implementation and administrative activities, not to exceed Six Hundred Fifteen Thousand, Seven Hundred and Twenty-Four Dollars (\$615,724) and authorizing the Interim City Manager or his designee to execute said Agreement; and containing an emergency clause. Motion by Mr. Stinnett, second by Mr. Monteleone that Council Bill No. 2020-400 be approved on an emergency basis. Voting in favor were Council Members: Brown, Colbert-Kean, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley and Stinnett, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance No. 2020-016**

Mr. Cortez introduced Council Bill No. 2020-500 - an ordinance amending the Annual Budget of the City of Joplin for the Fiscal Year 2018-2019 as adopted by Ordinance 2018-145 on October 15, 2018, to adjust appropriations; and containing an emergency clause. Motion by Mr. Cortez, second by Mr. Lawson that Council Bill No. 2020-500 be approved on an emergency basis. Mr. Stanley and Mr. Stinnett addressed the issue of emergency ordinances. They would like to have staff explain during the introduction of an emergency council bill what constitutes an emergency measure so that citizens will have a better understanding of the phrase “emergency clause”.

Vote to go into closed session, which shall pertain to the hiring, firing, disciplining, or promotion of an employee or particular employees of a governmental body involving personal information; as set forth in Section 610.021(3) RSMo, as amended, 2019. This meeting, record, and vote to be closed to the extent provided by law. The City Council shall adjourn at the end of the session. Motion by Mr. Cortez, second by Mr. Monteleone to go into closed session. Voting in favor were Council Members: Brown, Colbert-Kean, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley and Stinnett, 9. Nays: 0.
