News from the Public Information Office

Missouri's Severe Weather Preparedness Week is being observed this week, and to help Missourians prepare for potential tornadoes, one of the items planned is the annual Statewide Tornado Drill. This will be held at 10 a.m. tomorrow - Tuesday, March 8, weather permitting. This will be an opportunity for businesses, schools, and organization partners to review their tornado response plans in anticipation of the sirens sounding on Tuesday.

As part of the tornado drill, the City of Joplin will observe this by sounding the warning sirens for a full three minutes, - which is the same amount that would occur in an actual warning.

We encourage everyone to participate in the drill. Preparing today may make the difference in surviving the storms to come this spring. Citizens are encouraged to seek appropriate notification systems.

The City's sirens provide a warning for anyone who is out of doors to go indoors, if possible, and take shelter. People indoors cannot always expect to hear the outdoor warning sirens and we encourage residents to utilize a NOAA Weather Radio that provides a warning signal when the area is under a watch or a warning. There is an advantage of having a weather radio in your home – because you hear the alerts directly from the National Weather Service and are kept current of the warning status. Weather radios are available at local retailers. They come with directions, however if someone needs help in programming the radio, they can contact our Fire Stations or Keith Stammer, the City's Emergency Management Director and he can help them.

The City's Tree Limb and Brush Drop Off is open next weekend. It will be open from 8:30 a.m. to 2 p.m. on Friday, March 18 and Saturday, March 19. The drop-off site is located at 1702 North Schifferdecker Avenue, just about a half-mile north of Belle Center Road on the west side of Schifferdecker.

The program is open on the third Friday and Saturday of each month from March through October.

Mr. Cortez introduced Council Bill No. 2022-255 - AN ORDINANCE amending Ordinance No. 2004-256, passed by the Council of the City of Joplin, Missouri, November 15, 2004, by removing from District R-1 (Single-Family Residential) and including in District C-3-PD (Planned Development Commercial) property as described below and located at 2023-2047, 2101 & 2121 S. Highview Ave., City of Joplin, Jasper County, Missouri. Motion by Mr. Cortez, second by Mr. Lawson for denial of Council Bill No. 2022-255.


- Jim Scott regarding Iron Gates property
