The May 2, 2022, regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Doug Lawson.

News from the Public Information Office

The Joplin City Health Department has vaccinations available that are required for children beginning kindergarten and would like to help families ensure their child is prepared for this important milestone. If the child lives within the Joplin city limits or is enrolled in a Joplin public or private school, the Health Dept. can provide assistance. They provide immunizations for many insurances, the uninsured or underinsured, and those with Medicaid or Managed Care.

Parents and guardians are encouraged to obtain vaccinations now as they begin Kindergarten registrations. To schedule an appointment, call 417-623-6122. Please note that a parent or guardian ID and the child's insurance information and immunization record are required for the clinic visit. Immunizations will be given at the upper-level entrance (west side) of the Joplin Health Department, 321 E. Fourth Street.

The Joplin Recycling Center will offer a FREE Tire Drop-Off Event on Friday, May 20 and Saturday, May 21 from 9 a.m. to 3 p.m. at the Joplin Recycling Center located at 1310 West A Street.

Automotive passenger tires, with or without rims, will be accepted from Joplin residents and Joplin residential landlords. There is a ten tire per household limit. Commercial, large truck, tractor, or racecar tires will not be accepted.

This free event is funded by the City of Joplin as a community service. The collected tires will be hauled to a recycling facility where they can be made into playground cover, garden hoses, loading dock bumpers, road paving aggregate, running- and biking-friendly trail pavement, and much more! All metal rims will also be recycled.


