

**JOPLIN CITY COUNCIL
MAY 18, 2020
MEETING MINUTES**

CALL TO ORDER

The May 18, 2020 regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Gary Shaw.

INVOCATION was read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE to the United States of America was led by Mr. Monteleone.

ROLL CALL

PRESENTATIONS

Motion by Mr. Monteleone, second by Mr. Stanley to move the ceremonial presentation of Resolution No. 2020-009 to this portion of the agenda. Voting in favor were Council Members: Brown, Colbert-Kean, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley and Stinnett, 9. Nays: 0.

Mr. Monteleone read Resolution No. 2020-009. Mayor Shaw presented each education representative with a ceremonial copy of Resolution No. 2020-009. Receiving a resolution were Dr. Emily Yoakum, Principal of McAuley Catholic High School; Dr. Brad Hodson, Executive Vice President of MSSU; Dr. Alan Marble, President of MSSU; Dr. Melinda Moss, Superintendent for Joplin School District; Dr. Laura Rosch, Campus Dean for KCU- Joplin; Penny Williams, Franklin Technology Center-Adult Education; Melissa Smith, Director of Advanced Training & Technology Center for Crowder College; and Laura McDonald, Head of Thomas Jefferson Independent Day School.

Michael Keenan with Cochran, Head and Vick, presented the FY 2019 Audit Report. The results were: No illegal acts came to the attention of the auditors as a result of performing their audit procedures; no new accounting policies were adopted during 2019 in the City's Financial Statements; no difficulties or disagreements with management; and the auditors had full access to books and records. Other management letter comments included suggestions for best practices and possible improvements in internal control of the audit concerning personnel files and future accounting pronouncements.

Lori Haun, Downtown Joplin Alliance Executive Director, presented the Downtown Joplin Branding Implementation Update. She stated the presentation is a result of the branding consultant, Ben Muldrow of Arnett Muldrow and Associates who visited Joplin in January. Mr. Muldrow was asked to create a brand for Downtown Joplin. Ms. Haun stated they were thrilled by the community's response and candidness with Mr. Muldrow's process.

CVB Director Patrick Tuttle followed up with a presentation on rebranding for the City of Joplin. He suggested we build upon the work already done by Downtown Joplin Alliance. Cities cannot

be defined by a single image or logo. In general, a city can be defined by many attributes including, but not limited to, history and important moments, geography, parks, quality of life culture, education facilities, tourism and Main Street or popular neighborhoods. Successful rebranding can communicate what makes a municipality unique and appealing through a combination of visuals and words. Mr. Tuttle presented the Next Steps for Rebranding, which include getting Council’s approval to explore options; City of Joplin marketing efforts; COJ Department Use/Buy-In; Design & Cost; Implementation Plan; follow-up after 90 Days for Council’s Consideration. Motion by Mr. Stanley, second by Mr. Lawson to direct the City Manager to have staff proceed with the Next Steps. CITIZEN REQUESTS AND PETITIONS

Michael Hendrix discussed the Cruising Main Street Ordinance He asked if the city council would consider one of three proposed options in order to allow cruising on Main Street in certain areas. Option 1: eliminate the ordinance as it pertains to 10th and Main to 28th and Main Streets; Option 2: amend the ordinance to allow cruising up to 11:00 p.m., or option 3: give the organizers one Saturday a month where they are allowed to set up events, such as car shows, that would help bring the community together. Mr. Hendrix stated he and David Fort would organize the events. This would give South Main Street their version of Third Thursday. After discussion, the city council encouraged Mr. Hendrix to pursue this interest. They also suggested he get with the businesses in the area of interest and city staff to get their input and support and bring a plan back to the city council for consideration.

An additional request to address Council was submitted by Kevin Van Story, 1241 N. Business 49, Neosho. Mr. Van Story asked City Council to relax and remove all the restrictions on all the businesses in the community in order to move forward due to the amount of unemployed people in our area.

Candidates in the upcoming Joplin City Council election will be featured in a live Candidate Forum program airing at 6 p.m. Tuesday, May 26 on KGCS-TV. The forum will be held here in the Joplin City Council chambers. This forum will also be available for viewing live on the City's website. Citizens are welcome to attend the forum at City Hall, but due to social distancing requirements there will be a reduced number of seats available than during a normal Council meeting.

Judy Stiles, KGCS General Manager and host of the Newsmakers interview program, will serve as host. The eleven candidates will have an opportunity to address what they see as key issues facing the City of Joplin. In addition to airing live on KGCS-TV, the program will be rebroadcast later in the week on KGCS. The municipal election is being held on Tuesday, June 2 after the Missouri Secretary of State moved it from the original date of April 7 due to the coronavirus pandemic.

As Joplin residents begin warmer weather chores in their yards, the City's Stormwater Team reminds them to please mow the grass, so that cut grass is distributed upon their yard and not out into the street. Mowed grass, leaves & other yard debris accumulates at the road's stormwater drains, causing a hazardous clog to the stormwater system for Joplin roads.

City offices will be closed Monday, May 25 in observance of Memorial Day. Residential trash service will not occur on Monday so households will have their trash picked up one day later than their normal scheduled day. Monday's service will be picked up on Tuesday and the week concludes with Friday customers having trash service on Saturday, May 30.
