NEW BUSINESS

Discussion on K9 grants by Council Member Mrs. Reid Adams.

Mrs. Reid Adams stated she thinks keeping the current number of K9's is important so she searched for information on K9 grants and shared information on what she found, stating there are many opportunities available and feels it's beneficial for the city to pursue this option. Police Chief Matt Stewart stated one of the PD sergeants manages 90% of the grants for the PD so there would be an experienced employee to assist in this effort. Chief Stewart added that he had asked the sergeant in charge of the K9 program to look over the list of possible grant sources and after contacting a couple of the companies (National Association of Chiefs of Police and K9's for Cops) on Friday, July 13, the sergeant had not received a reply from either company. Chief Stewart stated there are some concerns that need to be addressed such as where the dogs come from, how to purchase them, training, etc. City Manager Sam Anselm stated that one of the issues with grants is to be mindful of the ongoing operations and maintenance costs of items that are purchased with grant dollars. In the case of a new dog for the K9 unit that would be purchased through a grant, we need to make sure it would be able to be sustained with the city's ongoing budget. Mrs. Reid Adams stated that K9's For Cops has dual purpose dogs with the bomb and drug sniffing dogs, the dog is provided as well as two weeks of training with the officer, we would just have to send the officer to the facility for that. In discussing this with Chief Stewart, we determined that the value of that would be about \$20,000. Mayor Shaw asked the council members if they were comfortable with allowing staff to look into this type of grant. The council consented unanimously. Mayor Shaw suggested that anyone with grant writing expertise is invited to volunteer to help with this project.

News and Announcements from Public Information officer, Lynn Onstot:

This Saturday the City is offering its free Tree Limb Drop Off program. Residents can bring their tree limbs and brush from 8:30 a.m. to 2 p.m., on Saturday, July 21. The drop-off site is located at 1702 North Schifferdecker Avenue, about a half a mile north of Belle Center Road on the west side of Schifferdecker. This service will be available on the third Saturday of every month through October.

Don't' forget – this Thursday is the Downtown Joplin's Third Thursday event. If you haven't had a chance to come downtown lately, this is a fun event to do so! If you can't make it Thursday, then perhaps you'll be here for Downtown Joplin's Sidewalk Sale – set for Saturday, July 28. Shopping starts at 7 a.m.

Just a reminder – Schifferdecker Aquatic Center will be closed this weekend for the Joplin Swim Team's annual swim meet. Cunningham will host Family Swim Night on Friday from 6:30-8:30 p.m., and both Ewert and Cunningham will be operating Saturday & Sunday from 1 to 6 p.m.

Comments from Council Members:

Mr. Stinnett commented on the Emancipation Days Golf Tournament that was recently held at Schifferdecker Golf Course. He stated former council member Morris Glaze wanted to express his appreciation to Mr. West for a great tournament, an enjoyable time and that Mr. Glaze's team won the tournament.

Mr. Monteleone extended an apology to Mrs. Colbert-Kean regarding a recent vote to allow a citizen extended time to address the city council. Mr. Monteleone cited Code Section 2-40 (b) that authorizes a council member to extend speaking time to an individual without a vote of the council.

Mrs. Colbert-Kean stated she would like to pursue establishing a youth (city) council. This idea was presented to the city council at the July 2 meeting by Van Johnson, an alderman from Savannah, GA. Mrs. Colbert-Kean would like to start by forming a committee comprised of interested school personnel, business men and women, city council members and citizen volunteers such as David Durall, who works closely with area youths and would like to see this project created. Mayor Shaw asked Mrs. Colbert-Kean to jot down some ideas on how to go about this first step of forming a committee. Mayor Pro Tem Stanley volunteered to help Mrs. Colbert-Kean on this project.

Mrs. Colbert-Kean commented that the National League of Cities (of which Joplin is a member), has a grant access program that would behoove the city to explore to see if there are any grants that we may be eligible for.

Mayor Shaw stated that Premier Baseball is back in town and that he would be presenting a proclamation on Tuesday, July 17, proclaiming July 18-22, 2018 as Premier Baseball Days.

Vote to go into closed session, which shall pertain to the hiring, firing, disciplining, or promotion of an employee or particular employees of a governmental body involving personal information as set forth in Section 610.021(3) RSMo, as amended, 2017, more specifically for the purpose of evaluating certain Council employees. This meeting, record, and vote to be closed to the extent provided by law. The City Council shall adjourn at the end of the session. Motion by Mr. Stanley, second by Mr. West to go into closed session. Voting in favor were Council Members: Colbert-Kean, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett and West, 8. Nays: 0. Absent: Brown, 1.

There being no further business, the meeting was adjourned at 8:15p.m.
