

**JOPLIN CITY COUNCIL
SEPTEMBER 16, 2019 MEETING MINUTES**

CALL TO ORDER

The regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Gary Shaw.

INVOCATION was read by City Clerk Barbara Gollhofer.

PLEDGE OF ALLEGIANCE to the United States of America was led by Mr. Cortez.

ROLL CALL

Answering Roll Call were Council Members: Taylor Brown (via phone), Melodee Colbert-Kean, Keenan Cortez, Doug Lawson, Anthony Monteleone, Diane Reid Adams, Gary Shaw, Ryan Stanley, and Phil Stinnett. Also, in attendance were Interim City Manager Dan Pekarek and City Attorney Peter Edwards.

PRESENTATIONS

Faron Haase, Joplin High School Student Council (JHS STUCO) representative, presented an update to City Council on various activities within Joplin schools.

Mayor Shaw presented a proclamation proclaiming the week of September 17-23, 2019 as U.S. Constitution Week. Connie and Clifford McQuillen accepted the proclamation.

Toby Teeter updated City Council on Project Hearthstone, which is a major retail company seeking to establish a 300,000 sq. ft. distribution center in our region. They anticipate 125 jobs at an average annual wage of \$51,895 and a \$40 million capital investment. The land is under contract. Chapter 100 bonds will be utilized on this project for both the real and personal property. The City will be utilizing up to \$100,000 of pre-approved Economic Development dedicated CDBG funds for the acquisition of a small parcel of land to give this site access to the road. Mr. Teeter further updated Council on: other ED business attractions, JIDA/Crossroads Industrial Park updates, and Entrepreneurial Ecosystem Development updates. There was discussion after the updates regarding council action to move forward with the Chapter 100 bonds. Motion by Mr. Stanley, second by Mrs. Colbert-Kean to ask city staff to draft formal documents to bring Chapter 100 Bonds to a future council meeting for Council's review. Voting in favor were Council Members: Brown, Colbert-Kean, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley and Stinnett, 9. Nays: 0.

She gave a brief description of Solace House and its concept, stating SHOTO is called a social model end-of-life care home (sometimes referred to in other states as a social model hospice home/house). This means the home is owned by the community and that it is funded by donations and no guest who stays there (or their family) receives a bill. On Friday, October 11 the *Stanley Cup* is coming to Joplin! The St. Louis Blues organization is providing the citizens of southwest Missouri a chance to see the highest prize in North American hockey. The trophy will be on display on the 1st floor of City Hall from 9 a.m. to 11 a.m. on Friday, October 11. We ask guests to please enter through the west door on the Joplin Avenue side of the building. There will be people stationed to help guide them to the display area. We will accommodate as many people as possible to view the trophy in the two-hour timeframe. Guests may have their photo taken next to it, however, the trophy cannot be picked up or moved. After our event, the St. Louis Blues organization will then head to Tulsa to showcase the *Cup* at the Tulsa Oilers season-opening game in the evening. The Oilers are an affiliate of the NHL's St. Louis Blues.

The Republic Services Transfer Station in Galena, Kansas, that accepts bulky items from Joplin residential trash customers, will be closed Saturday, September 21. To adjust for this closing, the Transfer Station **will be open on Friday, September 20th** from 8 a.m. to 2:30 pm for Joplin residential trash customers to dispose of bulky items.

Merchandise to be auctioned will be available for viewing from 1 to 4 p.m. on Friday, October 11, and from 8 to 9 a.m. Saturday, October 12, prior to the start of the auction.
