

**JOPLIN CITY COUNCIL
SEPTEMBER 17, 2018 MEETING MINUTES**

CALL TO ORDER

The regular meeting for the Joplin City Council was called to order at 6:00 p.m. by Mayor Gary Shaw.

INVOCATION read by City Clerk Barbara Gollhofer.

Comments from City Council:

Mayor Shaw thanked Director Haase for her comments and her work. He stated the City Council has a great deal of respect for all those who work for the City and the citizens. He stated Joplin has accomplished a lot of things since the tornado and it's time to look to the future to see what can be done to make Joplin the city we all want it to be. And part of that is to make sure all employees are in a position where they're making decent salaries. We all need to work together to find solutions to the financial constraints the City is facing while also being mindful of our fiscal responsibility.

Mr. Stanley asked the City Manager the status of the pay increase proposals that Council discussed at the August 22, 2018 work session. Mr. Anselm replied he's still in discussions with Fire Chief Furgerson. Mr. Anselm stated he hoped to have the information ready for the council by the end of next week.

Mr. Stinnett commented on Finance Director's statement that she is doing her job as directed by the City Manager, who is directed by the City Council. He stated Mrs. Haase does not set the guidelines, nor does she set what has been asked of her; but she responds to what has been asked of her. She has been treated unfairly in some cases. People need to realize that a lot of things done by department heads are because they're told to do so. They're just simply doing their job.

Mr. Monteleone stated he wanted to make a public apology for some things he said at the September 4, 2018 meeting that he felt were out of line toward Sam (City Manager), Troy (P&Z), and Ed Whitmore (City Planner). The comments regarded a Planning and Zoning issue that were based on assumptions instead of Mr. Monteleone asking questions. Mr. Monteleone stated he believes in what the City Staff does and stands behind what they do.

There being no further business, the meeting was adjourned at 7:01 p.m.
