The City's annual Auction is set for this Saturday, September 26. With more than 800 responses to the survey, we will hold a Public Meeting for the consultant to share some of the results along with ideas and program possibilities for Memorial Hall. This meeting will be from 4:30 to 6:30 p.m. on Thursday, October 1 at the Memorial Education Center. Many people might know this as the former Memorial school at 825 Pearl Avenue. As we discuss the preliminary concepts and review different options, we would like more input from our residents. Mark your calendars and watch the City's Facebook and the Parks and Rec page for another survey. This is the second of three meetings planned for this study of Memorial Hall.

We are also updating the City's Master Stormwater Plan and have two upcoming public meetings to hear from our residents about any water retention issues they may have near their homes or in their neighborhoods. The meetings are set for Thursday, Sept. 24 and Tuesday, Sept. 29. Both will be held from 4:30 to 6:30 p.m., with Sept. 24 meeting being held at the Housing Authority's community room at 5th and Turk; and the Sept. 29 meeting will be held at the Joplin Senior Center, 2616 Picher Avenue. All of the public meetings mentioned in these announcements are held in an Open House format, allowing a flexible schedule for people to come and go as their time allows.
