This is done through a series of signs posted in sequence along a short walking path. Each sign features a page of a children's picture book in sequence of the story. COUNCIL BILL NO. 2020-610

Christopher Beyer, Joplin, requested to speak on CB2020-610. He stated he was speaking on behalf of the Joplin Sports Authority have several concerns regarding the Parkwood lease agreement. At the end of his allotted speaking time of five minutes, Mr. Beyer asked for an additional minute to finish his comments. Motion by Mr. Copple, second by Mr. Monteleone to allow the additional time. Voting in favor were Council Members: Copple, Cortez, Lawson, Monteleone, Reid Adams, Shaw, Stanley, Stinnett and Williams, 9. Nays: 0. Mr. Beyer’s final comment was to ask the city council to consider tabling CB2020-610 to allow JSA to make a lease proposal of their own.

Forrest Reed, Joplin, requested to speak on CB2020-610. He asked the city council to allow JSA to provide a fully prepared and board approved proposal to lease various parks facilities.

Roger Doman, Joplin, requested to speak on CB2020-610. He asked the city council to please consider the JSA proposal.

After discussion to address the concerns of Mr. Beyer, Mr. Reed and Mr. Doman, Mr. Monteleone introduced Council Bill No.2020-610 - an ordinance approving a Lease Agreement by and between the City of Joplin and Parkwood Tournament, LLC, to lease various parks facilities; authorizing the City Manager to execute said Lease Agreement by and on behalf of the City of Joplin. Motion by Mr. Monteleone, second by Mr. Cortez that Council Bill No. 2020-610 be passed on Second Reading, advanced to Third Reading and passed. Voting in favor were Council Members: Cortez, Lawson, Monteleone, Shaw, Stanley, Stinnett and Williams, 7. Nays: Copple, Reid Adams, 2. The Council Bill was declared adopted and entitled **Ordinance No. 2020-170**
