Recap and Reference

The posted minutes of the Core Team meeting on April 13 speak to the nearly 25 recommendations received from the six Committees – Governance; Quality of Life; Healthy Living/Wellness; Positive Marketing & Branding; Job Growth; and Education.

The Core Team has narrowed those recommendations into two categories:

- 1. Recommendations for City Council resolutions, ordinances, or statements of support which require no City financial expenditures.
- 2. Recommendations that will require actions beyond resolutions or statements of support which may require City financial expenditures.
