

**On the 1<sup>st</sup> day of January 2017** a new Sentence Schedule for Court Costs, Surcharges and Fines will go into effect. As provided by law, on all Uniform Complaints and Summons (UCS) issued on that date and henceforth until changed by law and/or Administrative Order, Court Costs will be a total of \$31.50. The following Sentence Schedule for Fine and Court Cost for violations payable through the Violations Bureau (Non-Mandatory Court Appearance Violations) went into effect on any and all UCS issued on or subsequent to January 1, 2017.
