RESOLUTION NO. 2019-012

A RESOLUTION stating that Main Street Axe Company LLC has complied with the City of Joplin's requirements for a city liquor license.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF JOPLIN, MISSOURI, as follows:

Section 1. That Main Street Axe Company LLC's address is 215 S. Wall Ave., Joplin, MO 64801 ("the Property").

Section 2. That Main Street Axe Company LLC has applied for a city liquor license.

Section 3. That the Property is zoned C-2.

Section 4. That the applicable setback distance for alcohol sales from any hospital, church, or school is three hundred feet (300').

Section 5. That the distance, in feet, measured from the main public entrance of the Property to the main public entrance of the nearest school, church, or hospital is six hundred fifty-six feet (656') at 212 S. Joplin Ave.

Section 6. The applicable setback distance for alcohol sales from any private residence is one hundred fifty feet (150').

Section 7. That the distance, in feet, measured from the main public entrance of the Property to the main public entrance of the nearest private residence, which includes a single family residence, or multi-family use, but does not include a portion of a building zoned for commercial use, which is presently used as a residence is five hundred fifty-eight feet (558') at 201 S. Pearl Ave.

Section 8. That the City Council of the City of Joplin hereby states that Main Street Axe Company LLC has complied with the City of Joplin's requirements for a city liquor license.
