News from the Public Information Office

Joplin Public Library is hosting an Anniversary Celebration and invites everyone to join them as they celebrate two major milestones – 120 Years of Service to the Joplin community & 5 Years in their new facility on 20th Street!

The Anniversary event is Sunday, June 12 from 2 to 4 p.m. A formal welcome will take place at 2 pm, then following this, guests will be encouraged to take part in activities throughout the Library during this come-and-go format. There will be live music and refreshments for everyone to enjoy, and all ages are welcome to the free event.

Big BAM (Bicycle Across Missouri) is partnering with Joplin for the June ride that will begin from Landreth Park next week.

The Big BAM Ride is a 6-day cycling event across Missouri that will follow historic Route 66 from Joplin to Eureka, MO. Cyclists will depart Joplin's Landreth Park the morning of Monday, June 13th, and ride across the state finishing on June 18th.

The public is invited to Joplin's Landreth Park on Sunday, June 12th to welcome the cyclist to Joplin. Ceremonies to kick off this year's ride will begin at 6:30 p.m. from Landreth

Park amphitheater stage. The singing of the National Anthem, our Mayor's Welcome, and Rider Day 1 safety announcements will take place, followed by a public concert by THE SMITH BROTHERS.

Participants of the BIG BAM Ride will camp overnight in Landreth Park Sunday, then depart Monday morning between 5:30 and 10:00 a.m. We encourage all drivers in the Landreth Park area to be aware and watchful of riders departing at first light until 10 a.m. Cyclists will travel along Broadway Avenue and North St. Louis as they begin their journey

Joplin's Visitors Bureau is organizing this welcome and send-off event. The sponsor of the Big Bam, Ride is Missouri *Life* Magazine.

The Missouri Department of Transportation is seeking public input about a project for improvements along Missouri Route 66, - which is 7th Street here in Joplin. MoDOT wants to hear comments about this roadway between Schifferdecker Avenue to Range Line Road in Joplin.


