AUGUST 1, 2022
MEETING MINUTES**

CALL TO ORDER

The August 1, 2022, regular meeting of the Joplin City Council was called to order at 6:00 p.m. by Mayor Doug Lawson.

INVOCATION was read by City Clerk Holly Nagy.

RESOLUTION NO. 2022-010

Mr. Copple introduced Council Bill No. 2022-141 - AN ORDINANCE authorizing the acceptance of a grant from the Federal Aviation Administration Airport Improvement Program (FAA-AIP) for the Terminal Area Master Plan Design Services at the Joplin Regional Airport and authorizing the City Manager or his Designee to execute the agreement on behalf of the City of Joplin; and containing an emergency clause. Motion by Mr. Copple, second by Ms. Williams that Council Bill No. 2022-141 be passed on an emergency basis. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance No. 2022-120.**

COUNCIL BILL NO. 2022-142

Mr. Stinnett introduced Council Bill No. 2022-142- AN ORDINANCE authorizing the City of Joplin to enter into an agreement with McClanahan Construction Company Inc., in the amount of Four Hundred Ninety-Four Thousand and 00/100 Dollars (\$494,000.00) for construction services associated with the Turkey Creek Wastewater Treatment South Sludge Thickener and Septage Receiving on behalf of the City of Joplin and authorizing the City Manager or his designee to execute the same by and on behalf of the City of Joplin; and, containing an emergency clause. Motion by Mr. Stinnett, second by Ms. Spencer that Council Bill No. 2022-142 be passed on an emergency basis. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance No. 2022-121.**

Mr. Shaw introduced Council Bill No. 2022-523 - AN ORDINANCE approving the First Amendment to the 32nd Street Place Tax Increment Financing Redevelopment Plan; and containing an emergency clause. Motion by Mr. Shaw, second by Mr. DeTar that Council Bill No. 2022-523 be passed on an emergency basis. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance No. 2022-122.**

Mr. Copple introduced Council Bill No. 2022-524 - AN ORDINANCE approving Redevelopment Project 3 of the 32nd Street Place Tax Increment Financing Redevelopment Plan and adopting Tax Increment Financing therein; and containing an emergency clause. Motion by Mr. Copple, second by Dr. Farnham that Council Bill No. 2022-524 be passed on an emergency basis. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. The Council Bill was declared adopted and entitled **Ordinance No. 2022-123.**

ORDINANCES – FIRST READING**COUNCIL BILL NO. 2022-277**

Mr. Stinnett introduced Council Bill No. 2022- 277 - AN ORDINANCE establishing grades and accepting the Final Plat of Emerald Glades Plat 1 located at 3330 and 3332 N. St. Louis Ave., in the City of Joplin, Jasper County, Missouri. Motion by Mr. Stinnett, second by Dr. Farnham to strike Council Bill No. 2022-277. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. This item was stricken.

COUNCIL BILL NO. 2022-525

Mr. Cortez introduced Council Bill No. 2022-525 - AN ORDINANCE approving Redevelopment Project 4 of the 32nd Street Place Tax Increment Financing Redevelopment Plan and adopting Tax Increment Financing therein. Motion by Mr. Cortez, second by Mr. DeTar that Council Bill No. 2022-525 be passed on first reading and advance to second and third. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. The Bill was read as Council Bill No. 2022-525.

SECOND AND THIRD READING**COUNCIL BILL NO. 2022-131**

Mr. DeTar introduced Council Bill No. 2022-131 - AN ORDINANCE authorizing the approval of the 2022 Public Transportation Agency Safety Plan (PTASP) update detailing the safety processes and procedures for the City of Joplin, MO, Metro Area Public Transit System (MAPS) and Sunshine Lamp Trolley. This plan utilizes existing agency safety practices and Federal Transit Administration best practices to meet the regulations set in 49 CFR Part 673. Motion by Mr. DeTar, second by Dr. Farnham to pass Council Bill No. 2022-131 on Second Reading, advance to Third Reading and pass. Voting in favor were Council Members: Copple, Cortez, DeTar, Farnham, Lawson, Shaw, Spencer, Stinnett, and Williams, 9. Nays: 0. **Ordinance No. 2022-124.**


Set date for Public Hearing on Property Tax Levy for August 22, 2022.
